AMENDMENT #4 TO  
MEMORANDUM OF UNDERSTANDING

July 1, 2021 through June 30, 2024

BETWEEN THE CITY OF RIPON  
AND  
RIPON SERGEANTS' ASSOCIATION

On July 13, 2021, the City Council of the City of Ripon adopted Resolution No. 21-27, approving the 2021-2024 Memorandum of Understanding (MOU). The adjustments to wages, hours and conditions of employment that are set forth in this Amendment have been discussed by and between the bargaining representatives of the City of Ripon (hereinafter, "City") and the bargaining representatives of the Ripon Sergeants' Association (hereinafter, "Association") and shall apply to all employees of the City working in the classifications of Police Sergeant.

The City and the Association agree as follows:

ARTICLE I – SALARIES, Section M is hereby added to read in full as follows:

M. Sergeants who are assigned as the Police Administrative Officer shall receive Police Administrative Officer pay in the amount of 5% of their base rate of pay for each hour while the duties are being performed.

Except as amended herein, the 2021-2024 MOU and each term and condition contained therein shall remain unchanged and shall continue in full force and effect.
