AMENDMENT #1 TO MEMORANDUM OF UNDERSTANDING

July 1, 2018 through June 30, 2020

BETWEEN THE CITY OF RIPON AND RIPON CITY EMPLOYEES' ASSOCIATION

On July 10, 2018, the City Council of the City of Ripon adopted Resolution No. 18-59, approving the 2018-2020 Memorandum of Understanding (MOU). The adjustments to wages, hours and conditions of employment that are set forth in this Amendment have been discussed by and between the bargaining representatives of the City of Ripon (hereinafter, "City") and the bargaining representatives of the Ripon City Employees' Association (hereinafter, "Association") and shall apply to all employees of the City working in the classifications of Public Works Maintenance and Public Works Foreman.

ARTICLE VI - LEAVE

D. Due to the COVID-19 pandemic, the City of Ripon shall provide temporary leave to all full-time employees from July 1, 2020 to June 30, 2021. Association employees may take up to 5 days of temporary leave from their regular shift to mitigate the impacts of COVID-19. Leave shall be approved by the employee's supervisor and may only be taken as single days, unless approved by the employee's supervisor. If the leave is not used within this time period, the remaining hours shall not be paid out. If an employee separates from service during this time period, the employee shall not be paid for any remaining hours.

ARTICLE VIII - DURATION

C. The City and Association agree to continue the provisions of the current Memorandum of Understanding through and including June 30, 2021. In addition, the parties agree to a reopener to discuss possible compensation adjustments on or about January 2021.

Except as amended herein, the 2018-2020 MOU and each term and condition contained therein shall remain unchanged and shall continue in full force and effect.
